### The early years. Asylum as a political decision and judgement

- political asylum
  - Assange case, Haya de la Torre case
- explicitly excluded from the secondary legislation establishing the Common European Asylum System

- qualification of who is a refugee and who is a beneficiary of subsidiary protection (2004, 2011)
  - Presidential Decree 96/2008, Presidential Decree 141/2013, Law 4939/2022
- asylum procedures (2005/85, 2013/33)
  - Presidential Decrees 114/2010, 113/2013, Law 4375/2016, Law 4939/2022

# The first shock: the MSS judgment and the need to reform the Dublin acquis

- overhaul of the national asylum system
- 7 elements lacking from the previous asylum system, incl.
  - lack of access to an asylum procedure
  - lack of information on the procedure they had to follow
  - lack of interpreters and specialized staff to conduct the personal interviews
  - lack of legal assistance
  - excessive delay in issuing the decision
